



## eXPRS Pro Tip for CDDP, Brokerage, CIIS Staff Correcting OR542-DSA SPAs from Monthly to Weekly Frequency

## Did you know ...

## ... there is a way to correct OR542-DSA SPAs to change the frequency without having to void paid SDs?

There may be times that a CME authorizes OR542-DSA services but uses a monthly frequency instead of weekly frequency in error. This often results in the DSA provider only being authorized for 25 hours *per month*, instead of 25 hours per week, as intended.

If there has been nothing billed & paid against the incorrect OR542-DSA Plan Line/SPA, it can be voided & re-created using the correct frequency desired.

However, if there are paid SD billings against the monthly OR542-DSA PL/SPA, there is a work around to make corrections without voiding SD billings & claims.

1. Determine the last date billed for the monthly OR542-DSA authorizations & <u>END</u> the SPA(s) & Plan Line as of that date.

2. Create new Plan Lines/SPAs for OR542-DSA *at the weekly frequency* from the next date, going forward.

 Have your CME POC Super User update the monthly OR542-DSA Plan Line & SPA that was just ended to *INCREASE* the units authorized <u>to an amount that</u> <u>will allow WEEKLY billing</u>.

This means calculating the desired weekly limit by a conversion factor of 4.43 to get the monthly equivalent unit amount.

*Example*: 25 hours/week **x** 4.43 = **110.75** hours/month

• Be sure the individual has sufficient ANA monthly hours on their POC to support the new, higher monthly limit.

The new higher unit limit on the monthly frequency PL/SPA will allow the provider to bill 25 hours/week for that period of time.
